PART 1 - INTRODUCTORY PROVISIONS

Short Title

1.1 This Regulation may be cited as the Citizenship and Enrolment Forms Amendment Regulation.

PART 2 - CITIZENSHIP AND ENROLMENT FORMS REGULATION AMENDMENTS

Citizenship and Enrolment Forms Regulation amendments

- 2.1 The Citizenship and Enrolment Forms Regulation YFNR 1/2011 is amended as follows:
 - (a) by deleting section 3.1(g) and replacing it with the following:
 - (g) The execution of a notice of renunciation form must be witnessed by
 - (i) a solicitor, notary public or other person authorized by the Evidence Act (British Columbia) to take affidavits for use in British Columbia, or
 - (ii) the citizenship and enrolment registrar.
 - (b) by deleting the Form numbered DCS-4 in Schedule 1 to that regulation and replacing it with the Form numbered DCS-4 in Schedule 1 to this regulation; and
 - (c) by deleting the Form numbered DCS-5 in Schedule 2 to that regulation and replacing it with the Form numbered DCS-5 in Schedule 2 to this regulation.
