- 2. Opening Ceremonies/Welcoming remarks

Prayer given by Jeneva Touchie. Moment of silence was held. Opening remarks were made by President McCarthy.

3. Adoption of the Agenda

4. Executive Reports

Executive members provided updates on their respective portfolios for the time period mid-September to November 2023.

Chief Financial Officer, Tamara Nelson, reported back on two questions asked by Citizens at the last Assembly:

- Pearl Touchie had asked question about a note on financial statements that showed significant difference between 2022 and 2023 accounts receivable. Chief Financial Officer confirmed that the note is misnamed and that the difference is primarily related to housing, but the statements themselves are correct.
- Anita Touchie asked how much YG pays in legal fees. The CFO confirmed that in 2022 YG paid approx. \$360,000 in legal fees, and in 2023 YG paid approx. \$390,000 (\$128,000 of that will be paid from loan once specific claim settlement is received). To date in 2024, YG has paid \$284,000 in legal fees so far.

Citizen Jeneva Touchie raised concerns to leadership about the federal language funding that will be drastically reduced in upcoming fiscal year and urged them to keep that in mind.
