BACKGROUND:


- A. The Maa-nulth First Nations Final Agreement (“Maa-nulth Treaty”) has been amended in accordance with 1.14.0 of Chapter 1 General Provisions of the Maa-nulth Treaty.
- B. In accordance with 1.14.13 of Chapter 1 General Provision of the Maa-nulth Treaty, amendments to the Maa-nulth Treaty must be deposited in the Yuułu?ił?atł registry of laws and official records.

- 1) Under the authority of section 2.20(b)(iv) of the Government Act, the law clerk hereby deposits the following attached notice of amendment to the Maa-nulth Treaty in the registry of laws and official records:


In accordance with 1.14.11 of the Maa-nulth First Nations Final Agreement (the "Final Agreement"), notice is hereby given that on October 31, 2014 Toquaht Nation acquired District Lot 2240, Clayoquot District, from British Columbia in accordance with 2.10.7 to 2.10.13 of the Final Agreement and therefore, in accordance with 2.10.10 of the Final Agreement, Appendix B-3, Part 2(a) Plan 9 is deemed to be amended as shown on the attached Schedule to this Notice and Appendix D is deemed to be amended to include that portion of the Provincial Road shown as "Potential Crown Corridor" in Plan 1 of Part 3 of Appendix F-1 now bounded by the Maa-nulth First Nations Lands of Toquaht Nation.



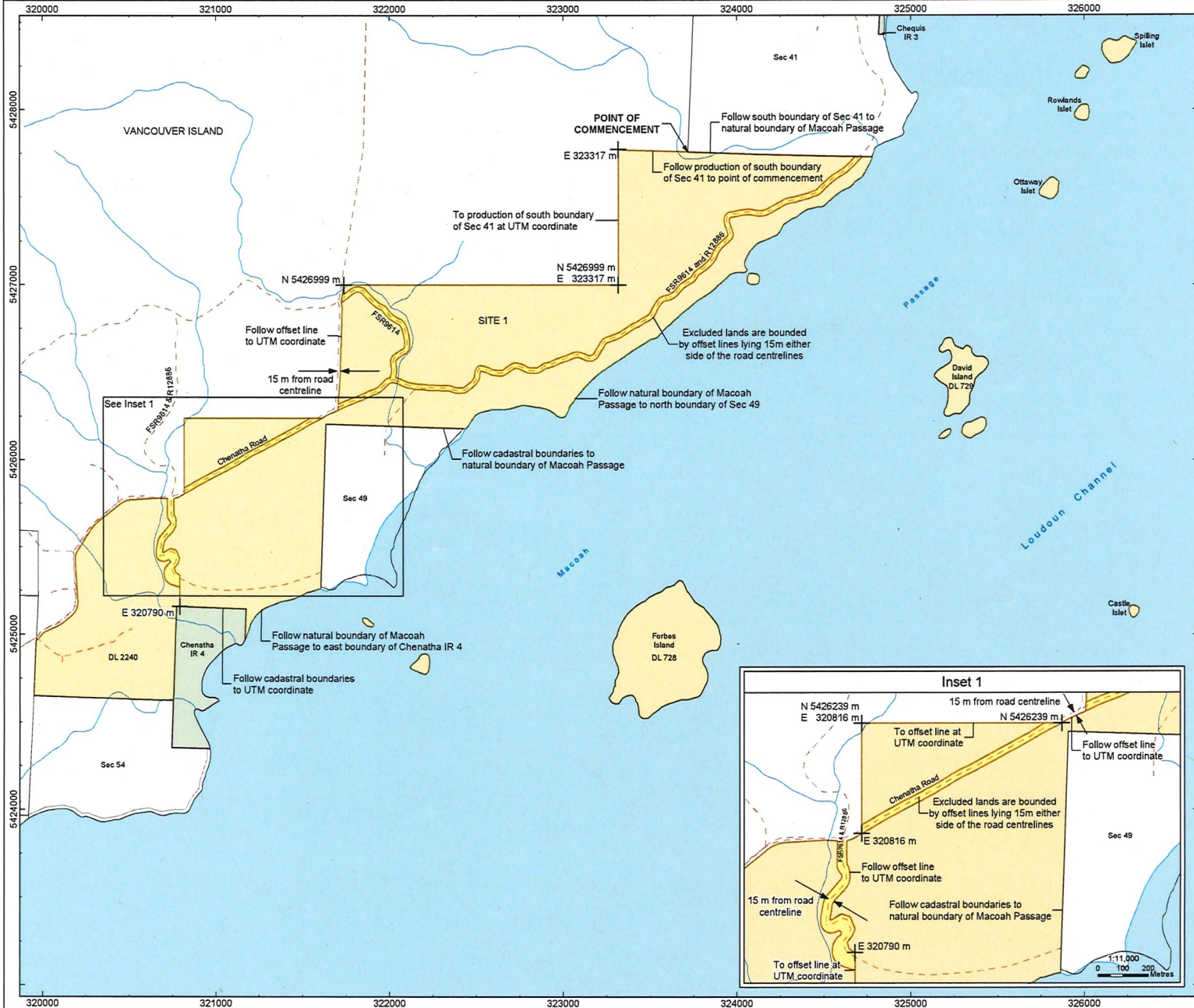

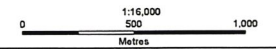


Maa-nulth First Nation Lands of Toquaht Nation

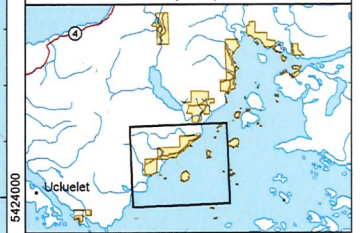


Point of Commencement

Site 1 - Southwest corner of Sec 41, Clayoquot District, thence clockwise

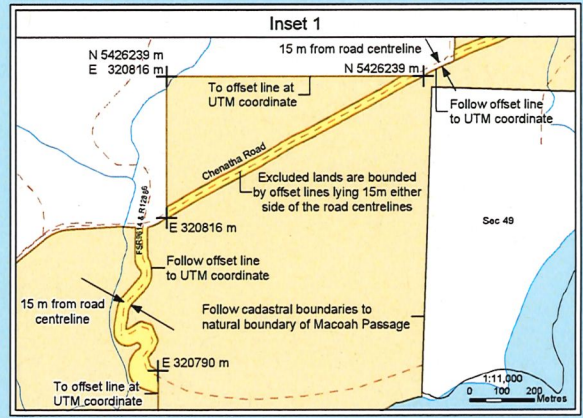

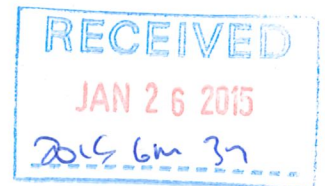
