BACKGROUND:

- A. The Maa-nulth First Nations Final Agreement (“Maa-nulth Treaty”) has been amended in accordance with 1.14.0 of Chapter 1 General Provisions of the Maa-nulth Treaty.
- B. In accordance with 1.14.13 of Chapter 1 General Provision of the Maa-nulth Treaty, amendments to the Maa-nulth Treaty must be deposited in the Yuułu?ił?ath registry of laws and official records.

NOW THEREFORE:

- 1) Under the authority of section 2.20(b)(iv) of the Government Act, the law clerk hereby deposits the following notice of amendment to the Maa-nulth Treaty in the registry of laws and official records:
 - a) In accordance with 27.3.1 of the Maa-nulth Treaty and as executed by all parties, the Implementation Committee is continued for a further 10-year period, through March 31st, 2031 on the same terms as set out in the Maa-nulth Treaty in sections 27.3.1 and 27.3.2.
- 2) The above amendment was effective on or about March 31st, 2021.

In accordance with 27.3.1 of the Maa-nulth Treaty and the expressed interest by all Parties to continue the Implementation Committee, this agreement confirms the commitment of all the Parties to the Maa-nulth Treaty to continue their participation in the Implementation Committee for a further 10-year period, through March 31st, 2031 on the same terms as set out in the Maa-nulth Treaty in sections 27.3.1 and 27.3.2. Prior to March 31st, 2031, the Parties look forward to discussing together a further extension of this commitment.


