

BACKGROUND:

- A. The Maa-nulth First Nations Final Agreement ("Maa-nulth Treaty") has been amended in accordance with 1.14.0 of Chapter 1 General Provisions of the Maa-nulth Treaty.
- B. In accordance with 1.14.13 of Chapter 1 General Provision of the Maa-nulth Treaty, amendments to the Maa-nulth Treaty must be deposited in the Yuułu?ił?ath registry of laws and official records.

NOW THEREFORE:

- 1) Under the authority of section 2.20(b)(iv) of the Government Act, the law clerk hereby deposits the following notice of amendment to the Maa-nulth Treaty in the registry of laws and official records:
 - a) The addition of the following parcels:
 - i) PID: 000-913-871 Section 36, Clayoquot District Except Part in Plan VIP75649;
 - ii) PID 009-389-873 Section 38 Clayoquot District Except Part in Plan VIP75650;
 - iii) PID 008-947-147 Section 40 Clayoquot District;
 - iv) PID 008-947-163 Section 41 Clayoquot District Except Part in Plan VIP84395; and
 - v) PID 008-947-201 Section 90 Alberni District (Situate in Clayoquot District) Except Part in Plan VIP75648 (collectively, the "Island Timberlands Parcels").
 - b) In accordance with 2.10.25 of the Maa-nulth Treaty, the Island Timberlands Parcels became Maa-nulth First Nation Lands of Toquaht Nation as of September 14, 2021 and Plans 4, 7 and 9 and the Additional Lands Index of Part 2 of Appendix B-3 of the Maanulth Treaty are deemed to be amended to reflect such additions as shown on Schedule A, attached hereto accordingly.
- 2) The above amendment was effective on or about September 14, 2021.

PID 008-947-201 Section 90 Alberni District (Situate in Clayoquot District) Except Part in Plan VIP75648.
