BACKGROUND:


- A. The Maa-nulth First Nations Final Agreement (“Maa-nulth Treaty”) has been amended in accordance with 1.14.0 of Chapter 1 General Provisions of the Maa-nulth Treaty.
- B. In accordance with 1.14.13 of Chapter 1 General Provisions of the Maa-nulth Treaty, amendments to the Maa-nulth Treaty must be deposited in the Yuułu?iŋ?ath First Nation Registry of Laws and Official Records.

NOW THEREFORE:

- 1) Under the authority of section 2.20(b)(iv) of the Government Act, the law clerk hereby deposits the following attached notice of amendment to the Maa-nulth Treaty in the Registry of Laws and Official Records:
 - a) The addition of PID 029-005-451, District Lot 357, Clayoquot District, Plan EPP21850, to the treaty lands of Uchucklesaht Tribe and deemed amendment to Appendix B-4, Part 2(a) Plan 9 of the Maa-nulth Treaty.
